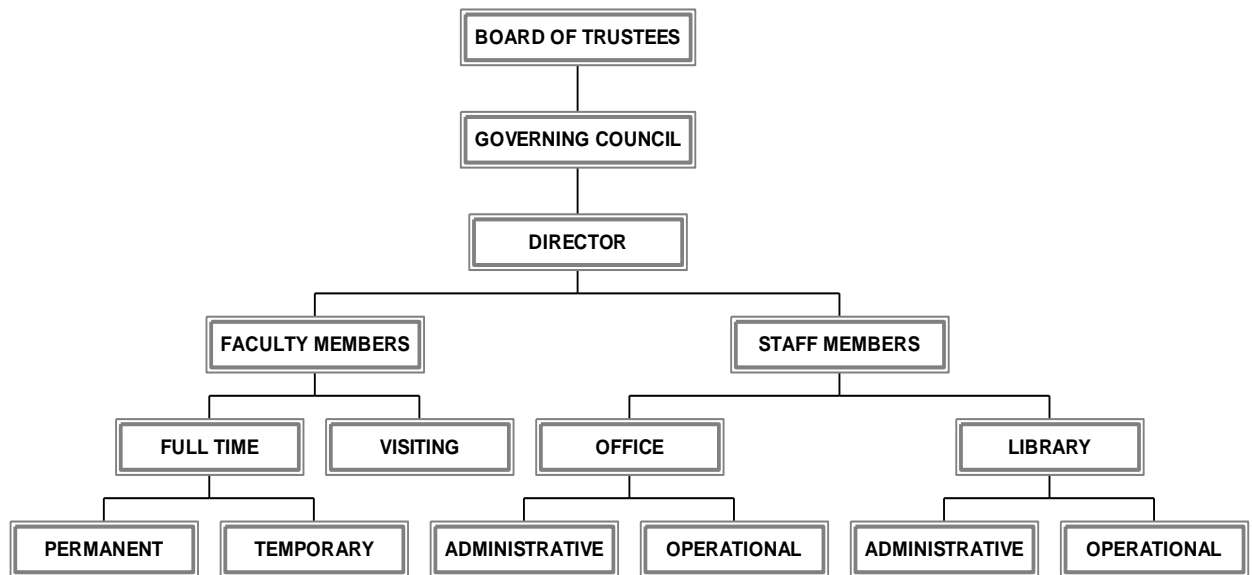

- CET would have multiple choice objective type questions. Each correct answer will carry **4** marks and each wrong answer will carry **1 negative** mark.
- Unanswered questions will carry **0 marks**.
- They will be no verification of marks or revaluation of answer sheets of the CET.
- The examination consists of **two papers** – 1) General Aptitude 2) Computer Concepts.
- The duration of examination 2 hours. Each paper has 25 questions and is expected to be completed in 1 hour.
